4. PUBLIC COMMENTS – Please state your name and the Town that you are from for the record. -Lois Pike stated that a tree branch is hanging on Robinson Hill Rd, near her home. -June Mosher asked the Town Manager and the Board of Selectmen to consider an incentive program to increase the number of residents who are connected to the town's sewer. She also stated that they also may consider balancing the rates charged to line up with the water bill rates. As it stands, her sewer bill is two-thirds more than her water bill.

5.5. Community Resilience Partnership Discussion

-Town Manager, Adam Garland introduced Claire McGlinchey from the Community Resilience Partnership/Ecology-Based Economy. Claire wanted to take another opportunity to discuss the benefits of the program. The Board of Selectmen stated as before in the January 19th, 2023 Selectmen meeting, that due to the required clauses, the Board of Selectmen chose not to enroll in the program. All thanked Claire for coming and presenting once again.

5.6. Accept a \$250 donation from William and Martha Booth to the Fire Department Reserve Acct -Floyd Thayer motioned to accept the \$250.00 donation from William and Martha Booth to the Fire Department Reserve Account. Caldwell Jackson seconded. Passed unanimously.

5.7. Accept a \$100 donation from Peter and Beverly Laverdiere to the Police Reserve Acct -Dana Dillingham motioned to accept the \$100.00 donation from Peter and Beverly Laverdiere to the Police Reserve Account. Floyd Thayer seconded. Passed unanimously.

5.9. Fire Department FY2023-2024 Budget Adjustment

-Adam Garland, Town Manager stated that the proposed budget amount for the Fire Department was over what was needed. The Board of Selectmen voted on \$953,027 for the department budget. The corrected amount is \$946,253. For clarity, the Town Manager is asking the Board of Selectmen to vote on the corrected budget figure of \$946,253.

-Caldwell Jackson motioned to accept the corrected amount of \$946,253 for the Fire Department Budget. Floyd Thayer seconded. Passed unanimously.

5.10. Review/Award Paving Bids (Whittemore Rd, Number Six Rd, Pottle Rd)

-Adam Garland, Town Manager reviewed bids received from the April 6, 2023 Board of Selectmen meeting on road improvement. The Town Manager is asking for the Board of Selectmen to vote on which roads, if any, they wish to move forward and to give permission for the Town Manager to sign contracts with the contractor :

- Whittemore Road, Reclaim-Gravel/base and surface pave
- Number Six Road, Reclaim- Gravel/base and surface pave
- Pottle Road-Shim and Overlay

-Board of Selectmen discussed the importance of the Whittemore and the Number Six Road being repaired. Dana Dillingham questioned what is on the agenda for next year's Roads. Adam Garland, Town Manager stated that the list has an additional nine (9) additional roads being considered. The Board of Selectmen acknowledges the CIP has the \$400,000 to go toward the roads, but do not want the fund balance drop below 1 mil. The Board of Selectmen is also requesting the Town Manager to

update the 97-1 fund balance to review by the next meeting.

-Caldwell Jackson motion to accept the Whittemore Road, Number Six Road, and Pottle Road for road repair and to approve the Town Manager to move forward in signing the contracts. Floyd Thayer seconded. Passed unanimously.

-Scott Hunter motioned to accept the bids for the Whittemore Road, Number Six Road, and Pottle Road with Pine Tree Engineering, Inc for the amount of \$806,053.00

5.11. Review/Award Bid for the Police Patrol Vehicle

Adam Garland, Town Manager reviewed the bid for the Police Patrol Vehicle that was opened on 4/12/2023. After reviewing the bids, Chief Jack recommends Quirk Auto Group for 46,743.00. *Caldwell Jackson motioned to award the bid to Quirk Auto Group for \$46,743.00. Floyd Thayer seconded. Passed unanimously.*

5.12. Town Sewer Discussion

Adam Garland, Town Manager reviewed the Town's sewer ordinance and rates, how many users are hooked up to the sewer and what the quarterly fee is received, and the loan fund information. The Board of Selectmen discussed the stand-by fee as stated in the sewer ordinance and how the grant money is being used. The Town Manager is drafting a plan to encourage more sewer hookups and planning to present this proposal to the Board of Selectmen at the 5/4/2023 Board of Selectmen meeting.

5.13. Recreation Department Parking Lot Discussion

As requested by the Board of Selectmen, The Town Manager, Adam Garland worked with engineer Rob Prue of Pine Tree Engineering to provide an estimation for paving the Recreation Department Parking Lot. Pine Tree Estimation would be \$91,000. Discussion and agreement were held by the Board of Selectmen that this is a future project that does need to be resolved. In the interim, the town manager will look into gravel or reclaim and roll out would be a temporary solution.

7.1. Present Draft Town Meeting Warrant

-Town Manager reviewed the conversation with the DEP regarding the location of the cans at the transfer station. The DEP stated that due to the flood zone in the lower field repositioned them with ramps.

-Discussion held by the Board of Selectmen and the Town Manager, Adam Garland regarding the water levels for Hogan and Whitney Pond. The Town Manager stated that there is a water scale that Inland Fisheries had put in to view the water levels at any time.

-Floyd Thayer asked about the bids for Rabbit Valley Road due to a resident concern. The Town Manager, Adam Garland stated that the same resident contacted him and directed him to a resource that would help him better. As far as the Rabbit Valley Road solution there is a hold due to the federal grant funding would not be available for another year

-Dana Dillingham brought up a concern regarding the mutual aid for Fire/Police and how there is very little reciprocation from other towns if Oxford is in need of their help. After a discussion, with Chief Jack, Fire Chief Paul Hewey, and the Board of Selectmen. The Board of Selectmen would like the Town Manager to contact the surrounding Towns and discuss this matter with them.

-Scott Hunter stated that parts of Allen Hill Road have been washed out and need repair. The Town Manager will mention this matter to the Highway Foreman.

-Caldwell Jackson mentioned that perhaps the training of a new plow person, but there is quite a heap of sand and dirt accumulated after plowing and would need a repair on the Number Six Road. The town Manager will mention this to the Highway foreman.
