2. ACTION ON MINUTES

2.1. Action on minutes dated May 18, 2023

4. 5. BUSINESS ITEMS

- 5.1.Review/Approve Oxford American Legion Post, Fundraiser Toll Road Request Scott Hunter motioned to approve the Oxford American Legion Post Fundraiser Toll Road Request date of July 1st from 9 am 1 pm on Skeetfield Road next to the Legion Post. Dana Dillingham seconded. Passed unanimously.
- 5.2.Review/Approve Combat Veterans Motorcycle Association Christopher Henry Mass Gathering Application (1,000 4,999)
- -Caldwell Jackson questioned the Police Chief, Ricky Jack if they had problems in the past with this association. Police Chief, Ricky Jack stated that this association has had no problems in the past. Scott Hunter motioned to approve the Mass Gathering Application with attendees of 1,000 4,999 for the Combat Veterans Motorcycle Association. Caldwell Jackson seconded the motion. 6. DEPARTMENT HEAD REPORT

- 6.1. Highway Department Jim Bennett Rabbit Valley Road
- -Town Manager, Adam Garland presented to the Board of Selection the proposal of \$18,256 that the Highway Foreman, Jim Bennett has put together to correct the issues identified on the Rabbit Valley Road. It is the intention of the Town Manager, and the Highway Foreman to work with the Hogan and Whitney Pond Association to address the drainage issues identified and see what resources can be shared, and/or perhaps ask an engineer to come in to look at the problems.
- -Jim Bennett, Highway Forman presented concerns regarding Rabbit Valley Road regarding the muchneeded repair. Even though repairing the culverts is needed it would be only a temporary fix due to the increased heavy rainfalls that have been happening more frequently.

- -Terri Coolidge stated that the damage of the recent heavy rains is causing erosion to the mouth of Hogan Pond. What is needed is rip rap on both sides and the ditches need a lot of work. Along with yearly maintenance of the culverts.
- Sharon Jackson, Chair stated that she supports hiring an engineer to set us in the direction of what could be done and to capture the cost of what is needed. In the interim, maintaining from here going forward until the bid process.
- -Caldwell Jackson stated that he was concerned with the work that is needed would take the Highway Department away from other roads that would need attention.
- -Scott Hunter stated that due to more frequent storms he would like to see a road project that would consist of culverts and underground work with a curbside such as what is on the back side of Allen Hill. Caldwell Jackson motioned to bring in an Engineer to look at Rabbit Valley Road. Scott Hunter seconded. Pass unanimously.
